## **President's Report**



My school district has seen a steady decline in the number of students taking shop class. The reason for this is due to several factors.

- School district funding is less so administrators do not have the ability to allow smaller classes, so they cut them.
- 2. Shop classes are larger; kids get less one on one time with the shop teacher and thus get frustrated.
- 3. Shop classes are larger; kids get less access to tools and machinery.
- 4. Very little machine replacement budgets, so often pieces of machinery are not functioning.
- 5. Old machinery needs replacing.
- 6. Too many bodies in the shop space to safely supervise and provide instruction/guidance, so students are given simpler and smaller projects to make.
- 7. Material and operating budgets are too small.

I am going to stop there, as the list can be continued, but the general idea is taking shape. The bottom line is fewer opportunities for students wanting to work in a metal shop, woodshop, auto shop, electronics shop and a drafting room. As the president of the Technology Education teachers, I would very much like to be able to change this trend. The sad part of this position is that I realize that I cannot. School district funding is decided by the government, and the Ministry of Education gives direction to the government. Our union negotiates on behalf of us, but we are all considered equal, so no special class sizes or funding for us. The things that I feel that I have played a part in are: working with the Industry Training Authority (ITA), to help shop teachers with materials for trades related courses (Skills Exploratory \$100 per student, Trade sampler \$250 per student); BC Construction Association to fund project shop class and distribute some tools; and facilitating more shop teachers sharing information via social media.

Moving into this new school year, I feel my next challenge is going to be identifying some best practices with the implementation of the new curriculum. One of my personal goals is to get ADST, the technology education component, started in elementary schools so kids use tools and materials at school, even if they do not use them at home, such as it was in the past. With this early start I hope that kids will have a desire to continue with shop classes when they get to high school. I will share what I do via Facebook. The new curriculum seems just great at the elementary level, however being old school, and being a very strong believer in skill building as the most important part of Tech Ed, I need to see how the new curriculum is going to actually help keep shops alive and hopefully flourishing.

This discussion leads me into how. The annual conference is one of the best ways to bring us together so we can share ideas. It allows us to discuss face to face issues and to feel a part of something larger than our silos at school. Facebook has proven to be a great addition to sharing expertise. The new BCTEA web site continues to expand and grow so that it can be a useful resource. At the conference we have created a workshop at the end of the day called Future Directions. At this workshop I would like to hear ideas to help move us forward. There will be a panel at the front to answer questions, but the main intent is to hear from you. Following this workshop will be our annual general meeting where you get to elect BCTEA executive officers, and help guide what the exec works on next year.

I know everyone cannot attend the conference and if you are reading this VIEW edition you obviously want to be a part of keeping shops alive, so please renew your membership and support our association.

I do intend to put my name forward for one more term as president. I am a strong believer that we need people on the executive that are willing to put in extra effort over and above their regular job to help do as much as is possible to keep Technology Education alive and flourishing. Having some turnover each year is good, so think about putting your name forward for a position and be prepared to share what you would like to do if elected.

As communications officer you are tasked with keeping all aspects of the website up to date, passing on all communication (through the website and/or email) with the PSA to the appropriate people and producing all the communications to/for the PSA and general public. As well, monitoring the Group Facebook Page.

The first year on the executive I started a database of teachers around the province, digitalized the View magazine and called it the Eview and started a Facebook Group page for Tech Ed teachers **ONLY** that now has 263 members (over 1/3 of all Tech Ed teachers).

This past year I took on the challenge of updating the <u>BCTEA.org</u> website. It is now improved, has a much better feel to it, allows subscribers to follow it and allows for posting of blogs and events by executive members. All conference info is now on the website for Tech Ed teachers to see and it also has a section called "Teaching in BC" that has a contact for each district for people interested looking at employment.

Finally, this fall, I have taken on the challenge of updating the database of all Tech Ed teachers in the province for this school year to be more than 95% accurate. This fall, it also includes ALL students at BCIT, UBC, retired teachers from last year and what people are teaching. I am currently working on a Web Application for the executive so we can search the database and be better informed as to what is happening around the province.
